1. Voucher Issuing and Tour Operator's Task

- The Kärnten Card will be issued **by the Tour Operator as their own voucher which must, however, be presented to the IGKC in advance as an example.**
- This voucher can be redeemed by customers at any Kärnten Card issuing office.
- The Kärnten Card must be presented in summer catalogues respectively internet, taking into account the conditions of use for the activation of Kärnten Card.
- In case Kärnten Card prices are listed in the catalogue, they must be final retail prices.
- The Kärnten Card can only be sold with an overnight stay in Carinthia and not independently, i.e. without an overnight stay in Carinthia.
- **The original voucher (no fax copy!) issued by the Tour Operator must contain the following information:**
 - customer's arrival and departure date;
 - customer's first and last name;
 - customer's address;
 - customer's date of birth;
 - serial number.
- The Kärnten Card is only valid with a photo ID; checks are possible at any time. If the card is misused or wrongfully transferred, it will be immediately confiscated. IGKC general terms and conditions apply.

2. Payment and Prices

The Kärnten Card 2019 will be issued at the following prices (including the VAT):

Free of charge for children born in 2013 or later and from the third child on.

Groups of 20 or more people receive the 21st Kärnten Card free of charge, groups of 30 or more the 31st and 32nd Kärnten Card. However, max. two (2) free cards can be issued per group.

Seasons:

Pre-season: 05/04/2019 – 09/06/2019

High season: 10/06/2019 – 14/09/2019

Low Season: 15/09/2019 – 27/10/2019

- a) Children born in 2013 or later are exempted from paying the ticket price and do not receive their own card. For the purpose of acceptance point check, you will be issued a pink cardboard card. No data collection is required for this cardboard card.

- b) At the purchase of at least one Kärnten Card for adults (parents or grandparents) and two Kärnten Cards for children (born in 2013), any additional children's Kärnten Card is free of charge.

The price on the arrival day will be charged.

The Tour Operator will receive a commission of _____ % on the above indicated prices.

The payment of redeemed vouchers will be made in one shot at the completion of the Kärnten Card season, end of October 2019, by direct withdrawal from the above indicated bank account.

*The IGKC calculates with a combined tax rate. The combined tax rate for 2019 will be announced by 28th February 2019.

3. Contract Term

This Contract begins when both parties have signed it and is limited to the Kärnten Card 2019 campaign term.
